ORDER

In supersession of all previous orders in this behalf, the following Judicial Magistrates of this District shall perform duties as MOD on the dates (24 hours) noted against each, with immediate effect, till further orders:-

S#	Name of Judicial Officer	Period of Duty Each Month
1.	Judicial Magistrate-I, DIKhan.	1 st to 05 th of each month.
2.	Civil Judge-I/JM, DIKhan.	06 th to 10 th of each month.
3.	Civil Judge-II/JM, DIKhan.	11 th to 15 th of each month.
4.	Civil Judge-IV/JM, DIKhan.	16 th to 20 th of each month.
5.	Civil Judge-V/JM, DIKhan.	21 st to 25 th of each month.
6.	Civil Judge-VII/JM, DIKhan.	26 th till end of the month.

Note:

1. If a Judicial Magistrate happens to be on leave or unavailable on the date of his duty, then the next duty Judicial Magistrate will be Magistrate on duty in his place for that day.
2. If all the above Judicial Magistrates at DIKhan are on leave or unavailable, the Civil Judge, senior in order of nomenclature i.e I, II & III etc available at DIKhan, shall work as MOD in place of them.
3. If any Judicial Magistrate at Kulachi, Daraban & Paroa is on leave or unavailable, the emergent criminal work pertaining to these courts shall be attended to by the Magistrate on Duty at DIKhan for those dates.
4. If any Judicial Magistrate at Paharpur happens to be on leave or unavailable, the next available Judicial Magistrate at Paharpur shall entertain and disposed of urgent criminal of that Court. However, when all the Judicial Magistrates at Paharpur are on leave or unavailable, the urgent criminal work of these Courts shall be attended to by the MOD at DIKhan.
5. In case, a Judicial Officer is proceeding on leave or unable to perform MOD during the notified date and time for any sufficient reason, he/she shall make his/her own alternate arrangement for the purpose and shall bring it into the notice of undersigned in writing well in advance and after approval may leave the station. In case there is no Judicial Officer to work as MOD on the gazette holiday, irrespective of the reason which forced the Judicial Officer to remain absent, the Judicial Officer who has been notified as MOD for the said day will be responsible for consequences by rendering himself/herself to the disciplinary proceedings.
6. In case of extreme/grave emergency, subject to the consent by other Judicial Officer for duty as MOD, the matter may be brought into the notice of undersigned subsequent and the Judicial Officer/MOD concerned may leave station without prior approval.
7. Each Judicial Officer shall be responsible for his/her MOD/duty assigned under Table *ibid*, especially after court hours and shall ensure his/her availability at their respective stations.
